Training provided to prospective teachers responds to the identified needs of the local educational agencies or States where the institutions graduates are likely to teach, based on past hiring and recruitment trends. The program partners with area school districts and charter schools. School districts tell us their needs and we in turn respond by making appropriate program adjustments. Training provided to prospective teachers is closely linked with the needs of schools and the instructional decisions novice teachers face in the classroom. The program has undergone a curriculum alignment process. Based on data analysis, we modified our courses to meet the needs of students and the school districts. Prospective special education preservice teachers receive coursework in core academic subjects and receive training in the delivery of instruction in core academic subjects. Special Education teachers are required to pass the same core academic subjects and state mandated examination as other students in the other certification fields.
